

Suppose you invite 10 first-generation users.

If each of your first-generation users invites 10 people, your second-generation users will total 10*10=100 people. You have 100 second-generation users. If each of your 100 second-generation users invites 10 people, your third-generation users will total 100*10=1000 people. Your team members include first-generation users Gen1 + second-generation users (Gen2) + third-generation users (Gen3): 10 + 100 + 1000 = 1110 people.

If each of your first-generation users earns 100 USDT per day, then your rebate is: 10*(100 *12%) = 120 USDT.
